6. Electronic bids must be submitted to the office of **Gandaki Rural Municipality** by hand/courier or through PPMO website www.bolpatra.gov.np/egp or before 12:00 on **2081/08/09**. Bids received after this deadline will be rejected.
7. The bidders are informed to attach supporting documents to verify the Qualification Criteria.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 2081/08/09** at the office of **Gandaki Rural Municipality**. Bids must be valid for a period of **30 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **2,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid.
